THE FOLLOWING PENALTY CHARGES MAY APPLY IF THESE ITEMS ARE FOUND IN YOUR SKIP: By signing the terms and conditions on the waste transfer note, you agree to these charges. Card details will be held until the load has been emptied and verified.

At this point they will be destroyed, however in the event that the load is overloaded, contaminated or hazardous waste is found in the load, your card will be charged accordingly.

ASBESTOS/MAN MADE TILE From	£3000.00 +VAT if not collected.
ASBESTOS/MAN MADE TILE From	£200.00 +VAT per bag if collected.
PLASTERBOARD NOT BAGGED From	£300.00 +VAT minimum fee.
OVERLOADED SKIP From	£100.00 + VAT – minimum fee
LATH AND PLASTER from	£300.00 +VAT – minimum fee
WASTED JOURNEY	£40.00 +VAT – minimum fee.
WAITING TIME	£30 +VAT per 15 minutes
TYRES	£50.00 +VAT – per tyre
FRIDGES / FREEZERS	£100.00 +VAT – per item
PAINT/OILS	£50.00 + VAT – minimum fee
TREE STUMPS	£100.00 + VAT – per item

1t, 2t, 3t, 4t, skips are hired for up to two weeks. 6t, 8t, 10t, 12t, 15t, 16yd, skips are hired for up to four weeks.

You must contact the company to arrange collection, failure to do so may result in a £1 per day charge if you exceed the original hire period.

**IF YOU ARE PUTTING SOIL IN THE SKIP,
IT MAY ONLY BE MIXED WITH STONE.**

**A “mixed” skip means you are not
permitted to put soil in the skip. A skip
for soil may only be mixed with stone.**

Card details will be held until the load has been emptied and verified. At this point they will be destroyed, however in the event that the load is overloaded, contaminated or hazardous waste is found in the load, your card will be charged accordingly.

Please take note of this update from the Environment Agency that outlines the banning of re-using, recycling and disposal to landfill of waste domestic seating due to the likely presence of Persistent Organic Pollutants (POPs).

The term ‘Domestic Seating Waste’ is to include sofas, sofa beds, armchairs, kitchen and dining room chairs, stools and foot stools, home office chairs, futons, bean bags, floor, and sofa cushions, and car seats.

This also includes items with any part made of or containing leather, synthetic leather, other fabric, or foam.

We know many of our clients are already aware of this information, however RAINBOW SKIPS are in a position where we must change our procedures as we are no longer able to accept domestic seating.

POPs remain intact in the environment for extended periods and if not disposed of properly become widely distributed geographically. They accumulate in the fatty tissue of humans and wildlife and have harmful impacts on human health and on the environment.

If an item of domestic seating waste is upholstered, you should assume that it contains POPs and manage it as POPs waste.

THESE NEW RULINGS BECAME EFFECTIVE FROM 1ST FEBRUARY 2023

All domestic seating is now an unacceptable waste and if any is found in the skip **IT WILL BE REJECTED**. You can no longer fill the skip with domestic seating waste, as it can no longer be re-used, recycled, or landfilled and the material must be sent to incineration to be destroyed.
