UNLESS AN EXTENSION IS AGREED IN ADVANCE, ADDITIONAL HIRE FEES OF £10 PER WEEK MAY BE CHARGED.

6T, 8T, 10T, 12T, 16YD, SKIPS. THE STANDARD HIRE PERIOD IS FOUR WEEKS. COLLECTION MUST BE ARRANGED THROUGH THE OFFICE.

UNLESS AN EXTENSION IS AGREED IN ADVANCE, ADDITIONAL HIRE FEES OF £20 PER WEEK MAY BE CHARGED.
